## MINUTES Black Creek Watershed Coalition Wednesday, November 13, 2002 Genesee Community College

#### 1. Introductions, assignment of roles, questions about minutes

#### 2. Consultant progress report

- Whitney handed out a table summarizing his review of the municipal comprehensive plans. The table describes how the plans address watershed planning objectives. It should be understood that just because something isn't listed doesn't mean the town doesn't do it (e.g. SEQR the State Environmental Quality Review). Page 2 of the handout describes the topics and factors related to watershed management that are shown on the table. Some highlights include:
  - The more rural towns tend to say, "Preserve prime farmland."
  - Larger towns appear to plan more thoroughly: they have more resources and more issues.
  - Every town appears to want to retain its rural character.
  - There is evidence that the towns are receptive to watershed planning. Common themes in the plans include preserving critical sensitive areas; preserve floodplain corridors, groundwater protection, and wetland protection.
- Ron Sloat read a letter from Seven Springs re: Biglow Creek to illustrate how a community may have concerns about water quality that aren't addressed in a comprehensive plan.
- Jim read the long-term flow record for Black Creek and noted that it has a large amount of variability for a stream of its size in NYS. Discharge can range from the single digits to 1000 cfs. Jim has prepared databases and maps for a lot of "point data" such as discharge permits, water quality monitoring sites, hazardous waste sites, etc., etc. He has a lot of data ready for tables to meet the objectives of the report.

Jim talked about Cornell's LEAPE (Locally-led Education and Action for Protecting the Environment) Program and his interest in applying this program to the Black Creek watershed.

**3.** The group reviewed and revised the draft objectives. This promoted excellent discussion. The revised objectives are attached.
