Action Items Underlined

Introductions, assignment of roles, changes to agenda, minutes: Introductions were made; Larry led the meeting; Rochelle scribed. The March 2011 minutes were reviewed and accepted.

Black Creek Watershed Characterization: <u>George, let Tom know if you got his e-mail.</u> <u>Tom,</u> <u>Rochelle, everyone: send George your comments on the draft characterization.</u> George has Peter's comments. Brian will incorporate these comments and then the BCWC will have a chance to review the next draft.

TMDL Public Meeting: The meaning of TMDL was reviewed. Phosphorus is the pollutant of concern in Black Creek. This study is no longer a "true" TMDL. Select handouts from the public meeting were presented and discussed. The model was discussed. The state MAY set 65ng/L P as a recommended limit. There will be a second presentation this summer. The first presentation generated may questions. The presentation was covered in the *Suburban News*.
