Citizen water quality monitoring

Pat reported she had sampled this morning. She said it seemed phosphorus was always high at the Mill Creek sampling site. She also mentioned that water levels were high this morning. She has noticed log jams at the site and there was some discussion about the Town's role in removing logs and debris from the stream.

Brian mentioned he has agreed to participate in the project but nothing much has happened to date.

Grants

Josh reported Monroe County SWCD had been awarded a WQIP grant for a portion of the Willowbank Drive – Village of Churchville project. Two phases of the original project will be funded. The third phase which involved dredging behind the dam was not funded.
