She indicated they are currently "tag-teaming" leadership over the Willowbank Drive project with the current District Staff. She said they are still in design phase, but hope to still build it this year. They have hit a few issues with legal easements and permitting.

Black Creek Watershed website update

Black Creek Fish Kill

George discussed and distributed a report on information he had collected regarding a report of large numbers of dead fish in Black Creek west of Churchville Park and west of the Route 19 bridge in Bergen. (See attached report) No apparent cause has yet been identified.

The DEC representative did say that the creek is clear for all water recreation. Thanks for sharing the info! BERGEN — Until an issue where many fish are dying in Black Creek in Bergen has been identified, the Bergen Rod and Gun Club has recommended to residents to refrain from fishing or letting their dogs swim in the creek.

On Friday, the Department of Environmental Conservation responded immediately to a report of a fish kill in Black Creek Watershed. There was evidence the event likely occurred Thursday or Friday.

"DEC responded to additional reports of the fish kill in the Black Creek Watershed throughout the weekend and into this week," said a spokesman from the DEC. "Based on the degree of decomposition, the kills appear to be from the same event."

DEC Region 8 Staff from the Fisheries, Water and Law Enforcement divisions continue to investigate the situation and no further information is known about the event or cause.

Black Creek is a Genesee River tributary which runs from Middlebury to Chili in Monroe County. It's 46 miles from start to finish.
